If you're invested in a unit linked fund

A unit-linked fund, otherwise known as an insured fund, is a fund that is linked to a plan issued by an insurance company that lets you combine your money with other planholders. If you are invested in a lifestyle profile, the unit linked funds you're invested in will depend on how close you are to retirement. You can see these by looking at your annual statement.
